- Nomination of the authorized applicant defined in the FCA :
 - **30 days** before the running day.
- Deadline for submitting the request to the COSS for ad-hoc requests
 - **30 days** before the running date. (FCA recomandation is 30 days)
- Integration of Croatia member from Novembre 2015
- Definition of PaPs on Multi corridors and Paps on overlapping sections
- For the management of AD-Hoc requests, the appliant will receive an offer not latter than 10 working days before the first day of train run.
- RFC6 is proposing to use the Flex PaP concept in Italy, Slovenia, Hungary.

SUMMARY OF RECOMMANDATIONS

PREPARING THE REQUEST WITH PAPs

- Prepara PCS dossier carefully checking the parametres of PaPs with feeder and Outflow
- Make sure the dossiers are coordinated with partners and at border points
- Check PCS status before TT deadline in order for COSS to pre-check the request
- ✓ Inform COSS for needed support

AFTER REQUEST

- Pay attention for alternatives proposals provided by COSS
 - ✓ Acceptance or refusal (Deadlines)
- ✓ Check the draft offer in July and make observation
- ✓ Check the final offer in August and accept or refuse it


GENERAL TERMS AND CONDITIONS DOCUMENT TO BE SIGNED BY APPLICANT

- According to the regulation 913/10 Art 15,Authorized Applicant may request International Pre-Arranged train paths on the corridor.....
- In order to manage this requirement in the most efficient way, from TT 2016 requests for capacity, RFC6 is implementing a new document to be signed by all applicants wishing to request capacity on the corridor for TT 2016
- This document is explaining what is necessary to be done regarding the obligations of the applicant towards the Infrastructure Managers and Allocation Body
- RFC6 will ask all applicants to sign this document prior to the Allocation of Pre-arranged path.
